

THE PATHWORK® FOUNDATION TRADEMARK AND COPYRIGHT POLICY

The Foundation reserves the right to update and change this policy consistent with the goals of the Foundation.

Definitions

Trademark and Service Mark

A trademark or service mark acknowledges ownership of the name of a product or service, and distinguishes that product or service from other products or services. Equally, the purpose of trademark and service mark law is to protect the public's right to rely upon a mark as a correct identification of the source of a particular and established product or service. Trademark and Service Mark law has a dual purpose in that it exists to protect the public, as well as the proprietor.

Copyright

Copyright acknowledges ownership of a unique work that is original and distinguished from other works, the work being viewed as intellectual property by law. As such, copyright is concerned with permission to quote and/or use material from the original work, and to protect the "property rights" of its owner.

I. Trademark/Service Mark Policy

Pathwork® is a registered service mark owned by the Pathwork Foundation, and may not be used without the express written permission of the Foundation. The name Pathwork® may not be used to identify groups, activities, products or services, nor may persons call themselves Pathwork teachers, counselors or helpers, without express written permission from the Pathwork Foundation. The Foundation may, in its sole discretion, authorize use of the Pathwork® mark by other organizations and persons, such as its affiliate organizations and chapters.

Any person or organization who receives permission to use the mark "Pathwork®" shall include the following notice in any publication or other medium which uses the mark:

"Pathwork® is a registered service mark owned exclusively by the Pathwork Foundation. It is used here with the permission of the Foundation. The mark may not be used without express written permission from the Pathwork Foundation."

Whenever feasible, the registration symbol ® should be used in conjunction with the mark "Pathwork®". By law the Foundation must retain the right to control the manner in which the mark "Pathwork®" is used and the services with which the mark is used. Any and all use of Pathwork® shall inure solely to the benefit of the Pathwork Foundation.

II. Copyright Policy

The copyright of the Pathwork® Guide lectures and all other Guide material channeled by Eva Pierrakos is the sole property of the Pathwork Foundation. The Foundation has registered its rights with the U.S. Copyright Office, and is protected throughout most of the world by international treaty.

Translation

No Guide material may be translated from English into another language without a translation contract with the Pathwork Foundation. All translations of the lectures must be made from the English text of either the 1996 Edition or the Unedited Lectures. “Complete Lectures of the Pathwork—Expanded Edition” is the source publication for translation of any other Guide materials including the Q&A’s.

Reproduction and distribution

The Foundation wishes to encourage the dissemination of the Guide material, and therefore permits reproduction and distribution of the Guide material under the following conditions:

- a) The text of the Guide Material may not be altered in any way, nor may the copyright, trademark or any other notices be removed.
- b) Lectures must be reproduced from the 1996 Edition or the Unedited Lectures. Q&A’s must be from the publication “Complete Lectures of the Pathwork—Expanded Edition”
- c) The lectures may be sold or distributed for no more than the cost of reproduction and distribution.
- d) The Foundation reserves the right to withdraw permission to disseminate the Guide material if the person distributing them violates any portion of this copyright and trademark policy, or otherwise violates the rights of the Foundation.

Use of Guide Materials in Publications and Electronic Media

- a) In general, Pathwork Guide material may not be used or quoted in written form, including audio, visual or electronic works, products or activities, or be used for advertising or commercial purposes, without the express permission of the Pathwork Foundation.
- b) As an exception to clause a) above, writers, authors and others who agree to respect and follow the rules stated later in this sub-paragraph b), can use portions of the Pathwork Guide Lecture material in book-length works, review articles and other works, in all media, whether now known or hereafter discovered or invented, under the following limitations:
 - i) The quoted portion of the Pathwork Guide material shall not be more than 250 (two hundred and fifty) words; and
 - ii) All use of Pathwork Guide material shall be properly cited and attributed (e.g. PL 220, or, QA 100); and
 - iii) All use of Pathwork Guide material shall contain proper copyright, trademark, and/or service mark notices; and
 - iv) The lectures quoted shall be either the 1996 Edition or the Unedited Lectures. Q&A’s quoted shall be from the publication “Complete Lectures of the Pathwork—Expanded Edition”
 - v) The user shall comply with the requirements of the "Fair Use" section of the U.S.

Copyright Act (Section 107 of the U.S. Copyright Act).

- c) Anything else in this Policy to the contrary notwithstanding, persons and organizations who have been expressly authorized to use the service mark may use quotations from the Guide material in publicity materials without special prior permission from the Foundation, provided that:
- i) All use of Pathwork Guide Material shall be properly cited and attributed (e.g. PL 220, QA 100).
 - ii) All use of Pathwork Guide Material shall contain proper copyright, trademark, and/or service mark notices.
 - iii) Lectures quoted shall be the 1996 Edition or the Unedited Lectures. Q&A's quoted shall be from the publication "Complete Lectures of the Pathwork—Expanded Edition"

These persons and organizations include, but are not necessarily limited to, affiliate organizations and chapters of the Pathwork Foundation, as defined in the Foundation Bylaws, and qualified Pathwork Helpers.

- d) In the case of requests where use of Pathwork Guide lecture material is more than 250 words, prior to granting use permission the Foundation must first review a manuscript copy of the entire unpublished work. If, after review, the Foundation gives use permission, then the Foundation may, in its sole discretion, request and set a royalty payment and may, in its sole discretion, require the execution of a contract which includes citation, attribution and disclaimer conditions. This guideline applies to newsletters, magazines, journals or periodicals, the Internet, World Wide Web and all other media, whether now known or hereafter discovered or invented.
- e) Abridgements, condensations, rewrites or derivative works of Pathwork Guide material, including but not limited to translations, must be approved by the Pathwork Foundation, as in clause d) above, prior to being submitted for publication.
- f) For those who receive permission to quote from The Pathwork Guide lecture material, the following copyright notice shall be included in each copy of the work, preferably on the copyright page:

"Quotation from the Pathwork® Guide Material ©(*insert year shown in copyright notice of the Pathwork Guide material*) the Pathwork Foundation. Reprinted by permission of the Pathwork Foundation."

- g) For those who receive permission to quote from the Pathwork Guide material in electronic media, the following legend shall be included on a clearly visible place acceptable to the Foundation:

"Quotation from Pathwork® Guide Material ©(*insert year shown in copyright notice of the Pathwork Guide e material*) the Pathwork Foundation. Reprinted by permission of the Pathwork Foundation."

- h) In all published writings or works that have been granted use permission by the Pathwork

Foundation, the Foundation requires that authors and writers, as well as editors of newsletter, magazines, journals and periodicals that deal with the Guide Material, place the following statement on the copyright page, or in the introduction, preface or editorial box:

"The ideas represented herein are the personal interpretation and understanding of the author and are not necessarily endorsed by the copyright holder of the Pathwork® Guide material."

This guideline applies to newsletters, magazines, journals or periodicals, the Internet, World Wide Web, and all other media whether now known or hereafter discovered or invented.

- i) All works which quote from or use portions of the Guide Materials shall include a proper service mark notice as follows:

"Pathwork® is a registered service mark owned exclusively by the Pathwork Foundation. It is used here with the permission of the Pathwork Foundation. The mark may not be used without the express written permission of the Pathwork Foundation."

- j) The Foundation reserves the right to change all or any part of this policy, including but not limited to the required copyright and service mark notices

III. Requesting Permission and Submitting Work

When permission is requested to use material from the Pathwork Guide material, the author or producer must also submit a copy of the work in which he or she is using it, and show how and where the material is cited. This specifically includes:

- a) A list delineating exact Guide quotes and/ paraphrases with citations (where they are found in the Guide material), and where and how they appear in the work.
- b) Citations and references to the Guide material in the work must either follow the material or appear as a footnote, or be placed in an index.
- c) A word-count sheet showing total number of words from the Pathwork Guide material being used in the author's work, with the percentage figure this usage number represents in the overall work.
- d) The copy of the work submitted must be accompanied by a self addressed envelope or container.

Any person or organization using the Pathwork® Foundation service mark or copyrighted material is deemed to have agreed to comply with the Foundation Trademark, Service Mark and Copyright Policy.
